3. Deputations

Greg Andrews. Covered structure and seating area at the cemetery

Councillor Greg Andrews provided the Committee with a brief overview of past initiatives to build a gazebo at the cemetery and requested that the Township re-consider the project. Councillor Andrews reported that a covered structure at the cemetery would provide patrons a space to gather that is sheltered from the elements.

The Committee discussed the proposal and potential funding options for the project.

Councillor Manners thanked Councillor Andrews for this presentation and informed him that the Committee will bring his request to Council for consideration.

Marilyn Capreol. Indigenous practices related to death and how that might be recognized at the cemetery.

Marilyn Capreol presented her proposal for the Georgian Cliffs Memorial Park Cemetery to incorporate a designated area for Indigenous burial ceremonies. Ms. Capreol recommended that the area include a covered structure for gatherings and pipe ceremonies and a contained firepit for scared burial fires. Ms. Capreol highlighted that the creation of this area could be an opportunity for two eyed seeing within the community.

The Committee discussed the proposal and recommended that the Township schedule a tour of the cemetery grounds with Ms. Capreol and Shawanaga representatives to discuss potential options.

Councillor Manners thanked Ms. Capreol for her time and informed her that the Committee will present her proposal to Council for consideration.

4. Other Business

2022 Budget - Update

Maryann Martin reported that 2022 budget will be presented to Council in April and most likely approved in May.

Promoting Cemetery – Update

Maryann Martin shared the updated cemetery advertisement that will be published in the Pointe au Baril Islanders Association yearbook. The Committee requested that the ad be circulated to Committee Members and ratepayer associations for additional advertising purposes.

Promoting Remembrance Day Banners

Greg Mariotti reported that Remembrance Day Banners can be purchased by community members again this year and that program will be promoted in the Township's Spring newsletter. Mr. Mariotti provided the Committee with a brief overview of banner photo requirements and associated costs.

The Committee discussed the topic and directed staff to arrange for the banners to be hung prior to Thanksgiving weekend.

New Cemetery By-law - Update

Maryann Martin informed the Committee that due to staff shortages at Bereavement Authority of Ontario (BOA), the Township has not yet received approval of the new cemetery by-law. Ms. Martin reported that once approval is granted, staff will update the Township website accordingly.

Spring Maintenance

Greg Mariotti reported that Public Works Staff will commence spring maintenance at the cemetery once the snow melts.
